

OFFICIAL RULES

NATIONAL GEOGRAPHIC KIDS ALMANAC CHALLENGE 2027 SWEEPSTAKES

NO PURCHASE IS NECESSARY AND A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. MANY WILL ENTER, FEW WILL WIN.

ENTRIES WILL NOT BE JUDGED. WINNERS WILL BE RANDOMLY SELECTED.

SWEEPSTAKES IS OPEN TO LEGAL RESIDENTS OF THE 50 UNITED STATES, D.C. AND CANADA (EXCLUDING QUEBEC) WHO ARE AT LEAST 18 YEARS OF AGE OR THE AGE OF MAJORITY IN THEIR JURISDICTION OF PRIMARY RESIDENCE (WHICHEVER IS OLDER) AND HAVE CHILDREN BETWEEN THE AGES OF 6-12 AT THE TIME OF ENTRY. ALL SUBMISSIONS MUST BE E-MAILED IN BY THE PARENT/LEGAL GUARDIAN OF AN ENTRANT.

SPONSOR

Sponsor is Penguin Random House LLC, publisher of National Geographic Kids Books, 1745 Broadway, New York, NY 10019 ("**Sponsor**").

TERM

The National Geographic Kids Almanac Challenge 2027 (the "Sweepstakes") begins at 8:00 a.m. Eastern Time ("ET") on May 5, 2026 and ends at 11:59 p.m. ET on September 30, 2026 (the "Entry Period"). To be valid, each entry must be e-mailed in to the address set forth below. Entries (as defined below) must be received electronically during the Entry Period. "Entries" (as described below) shall be referred to herein as an "Entry" individually and as "Entries" collectively. Entries become the property of Sponsor and will not be returned or acknowledged. Information on how to enter and prizes form part of these official rules ("Official Rules"). Entries will not be judged, and winners will be randomly selected. Winning a prize does not guarantee editorial placement in future Almanacs or online.

WHO MAY ENTER

Sweepstakes is open only to legal residents of the 50 United States, District of Columbia and Canada (excluding Quebec) who are at least 18 years of age or the age of majority in their jurisdiction of primary residence (whichever is older) and have children between the ages of 6 and 12 at the time of entry. All Entries must be submitted by a parent/legal guardian. Employees, officers and directors of Sponsor, its affiliates and subsidiaries (all such individuals and entities collectively referred to herein as the "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they live) or persons living in the same households of such individuals, whether or not related, are not eligible to enter or win a prize. SWEEPSTAKES IS VOID OUTSIDE THE 50 UNITED STATES, DISTRICT OF COLUMBIA AND CANADA AND IS VOID IN QUEBEC OR WHERE PROHIBITED OR RESTRICTED BY LAW. MANY WILL ENTER; FEW WILL WIN.

HOW TO ENTER

To enter, entrants must create both an artistic depiction of a shark and a brief description, which is then e-mailed in by their parent/legal guardian along with a Permission Form (as described below).

STEP 1: Entrants should create a shark with [a] unique adaptation[s]. The artistic depiction of the shark should show this/these adaptation[s], and the entrants should also write a brief description of the adaptation[s], how it/they help the shark, and what inspired the entrant to add it/them.

STEP 2: Permission Form – All entries must be accompanied by a completed Permission Form, which is filled out on <https://sites.prh.com/national-geographic-kids/almanac> (the “Website”) by the Entrant’s parent or legal guardian.

Parent/legal guardian: Complete the Permission Form, along with your child’s art and description at: <https://sites.prh.com/national-geographic-kids/almanac>.

Permission Form must be complete for Entry to be valid.

By submitting the Permission Form, parents or legal guardians agree to be bound by these Official Rules.

All Entries must be submitted by the parent/legal guardian of an eligible entrant.

Limit one (1) Entry per person. The limit does not apply to parents/legal guardians who may submit one entry on behalf of each child.

Partial or incomplete/piecemeal (e.g., including the artistic depiction and brief description, but not including a completed Permission Form in your submission, or including a completed Permission Form but not the artistic depiction and brief description) will NOT be accepted. Such incomplete Entries will be automatically disqualified and ineligible to win a prize.

Each Entry must meet the following “**Submission Requirements**”:

- Entrants can enter only one (1) Entry.
- Entry must be original artistic depictions.
- Name, date of birth, and age of Entrant at time of submission; name, home address (including country), and email address of parent or legal guardian of Entrant; must all appear on the Permission Form.
- Each Entry must be the submitting entrant’s own, previously unpublished work and not feature or focus on any material owned or controlled by third parties (unless the entrant can

provide written documentation of permission to use any materials owned by a third party in a form and substance determined by Sponsor in its sole discretion);

- As more fully set forth below, the entrant's parent/legal guardian must provide upon request all required consents, permissions and releases (including but not limited to releases from all persons appearing in the entry, location releases, and releases from all creative consultants or others who assisted in the creation of the Entry) for the Entry in a form and substance determined by Sponsor in its sole discretion (in the event an entrant cannot provide all required releases, Sponsor reserves the right, in Sponsor's sole discretion, to disqualify the applicable Entry, or seek to secure the releases for Sponsor's benefit, or allow the applicable entry to remain in Sweepstakes); and
- The Entry must not include content that is obscene, pornographic, libelous or otherwise objectionable (including, without limitation, including profanity, offensive language, nudity, and excessive violence);

Any Entry that, in Sponsor's good faith judgment, violates the Submission Requirements may be disqualified. Entries must be received by the deadlines set forth herein or as otherwise stated on the Website. Sponsor's computer clock will be the official timekeeper for this Sweepstakes. No substitutions of new versions of Entries will be accepted under any circumstances once the original Entry is submitted for consideration. Any Entry that is considered by Sponsor in its sole and absolute discretion to be obscene, pornographic, libelous, hate speech or otherwise objectionable, in whole or in part, or that disparages the reputation of Sponsor may be disqualified.

One (1) Grand Prize winner and five (5) Runner-up winners will be randomly selected. **Odds of winning a prize depend on the total number of eligible entries received.**

Selection will take place on or about October 30, 2026, and parents/legal guardians of the selected entrants will be notified in writing using the information provided at the time of Entry on or about November 30, 2026. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by the potential winner's parent or legal guardian for any reason. If, despite reasonable efforts, a potential prize winner does not respond within five (5) days of the first notification attempt, or if a prize or prize notification is returned as unclaimed or undeliverable to such potential prize winner, such potential prize winner may forfeit the applicable prize and an alternate prize winner may be selected. Canadian residents will be required to correctly answer a time-limited skill-testing question in order to be declared a winner. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the applicable prize for any reason prior to award, such potential prize winner may be disqualified and an alternate winner may be selected. Sponsor may successively attempt to contact up to five (5) potential prize winners of in accordance with such procedure, and if there is still no confirmed prize winner after such attempts have been made, if any, the applicable prize may go unawarded.

For the purposes of these Official Rules, the parent/legal guardian of an entrant will be deemed to be in receipt of Sponsor's request or notification, (a) in the event that Sponsor sends the request by postal mail, five (5) business days after the request was sent by Sponsor, or (b) in the event that Sponsor sends the request by e-mail, on the day that the e-mail was sent by Sponsor.

THIRD PARTY RELEASES

If the Entry contains any material or elements that are not owned by the entrant and/or which are subject to the rights of third parties, the entrant is responsible for obtaining, prior to submission of the photograph, any and all releases and consents necessary to permit the exhibition and use of the photograph in the manner set forth in these Official Rules without additional compensation.

Upon Sponsor's request, each entrant's parent/legal guardian must be prepared to provide (within 7 calendar days of receipt of Sponsor's request) a signed release from the owner of any material that appears in the Entry, authorizing Sponsor and National Geographic Partners and its designees, licensees and parents, subsidiaries and affiliates (collectively "**Authorized Parties**") to reproduce, distribute, display and create derivative works of the artwork in connection with the Sweepstakes and promotion of the Sweepstakes, in any media now or hereafter known, including, but not limited to display at a potential exhibition of winners; publication of a book featuring select Entries in the Sweepstakes; and publication in *National Geographic Kids* magazine or online highlighting Entries or winners of the Sweepstakes. All releases must be in the form provided by Sponsor. Failure to provide such releases upon request may result in disqualification at any time during the Sweepstakes and selection of an alternate winner.

Failure to provide such releases upon request may result in disqualification and selection of an alternate winner.

Finally, upon Sponsor's request, each entrant must be prepared to provide (within 7 calendar days of receipt of Sponsor's request) a signed written license from the owner of any private property included in the photograph entry, authorizing any Authorized Party to reproduce, distribute, display and create derivative works of the entry in connection with the Sweepstakes and promotion of the Sweepstakes, in any media now or hereafter known. Failure to provide such releases upon request may result in disqualification and selection of an alternate winner.

For the purposes of these Official Rules, the entrant will be deemed to be in receipt of Sponsor's request or notification, (a) in the event that Sponsor sends the request by postal mail, five business days after the request was sent by Sponsor, or (b) in the event that Sponsor sends the request by e-mail, on the day that the e-mail was sent by Sponsor.

WINNER VERIFICATION

PRIZES WILL BE AWARDED TO PARENTS OR LEGAL GUARDIANS ON BEHALF OF MINOR ENTRANTS. CANADIAN RESIDENTS WILL BE REQUIRED TO CORRECTLY ANSWER A TIME-LIMITED SKILL-TESTING QUESTION IN ORDER TO BE DECLARED A WINNER. PARENTS OR LEGAL GUARDIANS OF POTENTIAL WINNERS ARE REQUIRED TO EXECUTE THE FOLLOWING: (1) AN AFFIDAVIT OF ELIGIBILITY AND LIABILITY RELEASE; (2) WARRANTY OF OWNERSHIP AND LICENSE; (3) WHERE

KNOW-IT-ALL U.S. PRESIDENTS, UPDATED & EXPANDED by National Geographic Kids; and (h) IT’S A NUMBERS GAME! FOOTBALL by Eric Zweig foreword by Patrick Mahomes. The approximate retail value (“ARV”) of the Grand Prize is \$495.86 USD.

Five (5) Runner-Up Prize winners will each receive one (1) single copy of a National Geographic Kids book (each a “**Runner-Up Prize**”). The ARV of each Runner-up Prize is \$15.00 USD.

Prizes will be awarded only if the potential prize winner fully complies with these Official Rules. All portions of the prize(s) are non-assignable and non-transferable.
